

Fee Waiver Request Instructions

Registration fee waivers are offered based on need and are available to:

- **U.S. high school students** who currently qualify for a waiver of SAT or ACT testing fees, for a free or reduced-priced school lunch program, or for a minimum of \$4,500 in Federal Pell Grants.
- **U.S. students transferring** from a two- or four-year college are based on a student's qualification for a minimum of \$4,500 in Federal Pell Grants.

For a fee waiver to be processed, the attached form must be sent by the student's current school to the NAIA Eligibility Center. The student will be able to continue filling out the online registration form, but the NAIA Eligibility Center must receive this form before (s)he will be able to submit his/her online profile for review.

For an incoming freshman student:

The attached form must be sent from the student's high school guidance or principal's office.

For a two- or four-year college transfer student:

The attached form must be sent by the student's school's Office of Financial Aid.
